While we can relate to some specifics here, in the main it is impossible other than to give you an "idea" (and we would emphasize that) of our direction. Here goes!

- (Fact) The building (284 King St. E.) is sold. May of 1988 is our deadline to vacate, however from "day one" the purchasers have intimated their flexibility here if we had a problem in relocation.
- (Fact) We did receive several offers for the building from varied interested purchasers:

First offer	-	\$	650,000.00
Second offer	-	\$	875,000.00
Third offer and "sold"	-	\$1	,000,000.00

- 3. We are now dealing with the purchaser who has available a building we can "rent" that will meet our requirements. We tentatively have a gentlemen's agreement to consumate this transaction. This will be subject to the meeting of minds insofar as the legal jargon is concerned. (Col. John Lowndes is representing our Association)
- 4. (Fact) The location is 29 Leslie Street, Toronto.
- (Fact) We are looking at about 7,500 square feet, mainly on one floor, street level, however there is an area slightly lower, about 5 stairs.
- We presently are dealing with designers, contractors, etc. and while we come closer each day to putting it all together "no commitments have been made to date".
- 7. "If" all goes well and this deal is finalized, to meet our dollar needs at the new premises we will be looking at the funds received from the sale of 284 King Street being invested and the proceeds from the investment, hopefully will take care of the major portion of our expense. Bear in mind, however, we will be using a reasonable amount of our "basic million" to upgrade the new premises in the way of furniture, etc., that will provide the greatest comfort and joy for our members.
- If things jell in the next week or so, we could be looking at November '87 occupancy.
